ATHLETIC CODE OF CONDUCT / ASSUMPTION OF RISK / DRUG, ALCOHOL, & STEROID BAN / INSURANCE / PHYSICAL / CONCUSSION INFORMATION

STUDENTS:

Your participation in high school athletics is dependent on your eligibility. PROTECT that eligibility by reviewing with your parent(s)/guardian(s) this summary of the Patterson High School (PHS) Athletic Code of Conduct. Athletic programs contribute to the educational, emotional and social development of students. Since students are not required to participate in athletic programs the choice to participate in these programs is a privilege and students are required to follow the Code of Conduct to remain eligible to participate. For the purpose of this document "athletics" shall be defined as all sports and cheerleading. Students who choose to participate in athletics are expected to conduct themselves in a manner that reflects the values of the school and community they represent. In addition to the behavioral standards and disciplinary consequences applicable to all students in the District, each student desiring to participate in athletics must comply with the District's Athletic Code of Conduct.

PURPOSE OF INTERSCHOLASTIC ATHLETICS is to give students the opportunity to:

- o Develop organizational skills to balance athletics and academics
- o Learn new skills and improve existing ones.
- o Experience commitment and dedication to school, community, and academics
- o Develop physical vigor and desirable habits in health and safety
- o Learn what it takes to be a good teammate
- o Develop new friendships
- o Observe and exemplify good sportsmanship
- o Demonstrate truthfulness
- o Be dependable in fulfilling obligations and commitments
- o Accept responsibility for consequences of actions and not make excuses or blame others
- o Strive to excel
- o Persevere, give 100% effort and not give up in the face of setbacks
- o Control anger and frustration and refrain from displays of temper and bad language
- o Accept losing and winning graciously; to congratulate opponents, not sulk, or display other negative behaviors
- o Realize that athletic competition participation carries with it certain responsibilities
- o Learn that a violation of the Code has a consequence – and this same sequence occurs throughout endeavors in life

I understand that once I sign the eligibility statement all eligibility rules will apply. These expectations will apply 24 hours a day, 7 days a week, 365 day a year – from his/her date of enrollment through date of graduation.

PARENTS:

The reason for developing the District's Code of Conduct is not to punish those who break the rules. The Code of Conduct sets behavioral standards to assist youth in making good decisions. It also sets the clear and consistent boundaries for your son/daughter's participation in athletics.

REVIEW the following rules with your student. Your emphasis on the value of following these rules cannot be overstated.

CHECKLIST FOR STUDENTS ELIGIBILITY:

- o **If you cannot check all items, see your Athletic Director or Principal.**
- o Have a minimum of a 2.0 Grade Point Average from the most recent grading period. Note: Students with grade point averages less than a 2.0 will be allowed to participate in practice but are not eligible to compete in any CIF sanctioned events, unless otherwise determined by the Athletic Director.
- o Will not have turned 19 years old prior to June 15 before the start of their senior year
- o Physical exam on record prior to the start of the season
- o Will be in attendance all periods of the day, unless at a medical or dental appointment, or other rare situations (i.e. funeral, religious holiday) prearranged with the Principal or Athletic Director.
- o Have not transferred from another school within the past year. Note: Requires Athletic Director approval
- o Will not compete in non-school athletic events in my sport after reporting for the school team
- o Will not use, possess, sell or distribute tobacco products;

- Will not use, possess, sell, distribute or be under the influence of alcoholic beverages, illegal drugs or performance enhancing substances (e.g. steroids), whether legal or illegal, look-alike drugs, or drug paraphernalia on school grounds, off school grounds, whether during sport season or out of sport season;
- Will not host or remain present at events, activities or locations where **illegal** distribution of alcohol, drugs or another performance-enhancing substance are present or used.
- Will not use, possess, or distribute firearms, weapons or explosive devices on school grounds or at school events;
- Will not engage in threatening, hazing activities, bullying, vandalism, harassment, or other personal misconduct, including, but not limited to, witness intimidation or harassment and conduct that involves police or court action.
- Students will not engage in cyber-bullying, participate in sending or creating inappropriate cyber images or be seen in an inappropriate cyber image.
- Every participant and his/her parent/guardian will be apprised of the Athlete Code of Conduct in the required Patterson Life of a Tiger presentation conducted at the beginning of each sports season. Every athlete is **required to attend** the Patterson Life of a Tiger presentation with at least one parent/guardian.
- Any student failing to return or pay for lost or damaged sports equipment (uniforms, etc.) will be suspended from future participation until restitution is made.
- School principals will direct the development and implementation of any needed school regulations and/or forms to implement this procedure.
- I agree to full cooperate in any investigation honestly and truthfully.

*For purposes of this section, "possess" shall be defined as having in one's possession or control, e.g. on one's person or in one's physical control, or to have in one's presence, property, or close proximity to be used in an **illegal activity**.

Parent Responsibility

Parent and guardians are essential partners in maintaining a safe, educational and enjoyable experience for students. When present at the District's events, including athletic games and practices, they are expected to model the kind of citizenship and sportsmanship that is expected and required of students. Learning to deal with conflict is a life-long skill for all students. Therefore it is important that the student speak with their coach regarding any issues. If a student speaks with their coach and is not satisfied after the conversation, the next step will be for the student, parent and coach to meet. If satisfaction is not reached at that level, the student and parent may meet with the Athletic Director. If satisfaction is not reached at this level, the student and parent may meet with the Principal. Coaches determine playing time with the intent of providing the team with the best opportunity to be successful. The following are among the District's expectations for the parents of student athletes.

Parents/guardians:

- Have **knowledge, understanding and agreement** about the Rules and Conduct/Standards, included in this document.
- Know the consequences for violations of those Rules and Conduct/Standards, and will assist in their enforcement.
- Are supportive and encourage their children to demonstrate appropriate behavior while representing the District as student athletes.
- Hold their children accountable for their actions and guide them in making proper decisions regarding drugs, alcohol and tobacco.
- Hold their children accountable for their behaviors towards others ensuring that their student does not bully or harass others and that their student is not a bystander to this behavior.
- Are knowledgeable about individual team rules and expectations and address concerns regarding their children's program to the coach/staff.
- Are knowledgeable spectators, knowing the rules of the game and serving as role models for sportsmanship. They cheer our successes, and show understanding in the wake of defeat. They encourage the efforts of their children's teams, and they respect the efforts of the opposing teams.
- Adhere to state laws that prohibit smoking on school grounds or in school buildings.
- Bring their concerns to the attention of the appropriate coach (es), including concerns about the mental and physical treatment of their children, ways to help their children improve, and their children's behavior. They schedule meetings with coaches in order that their concerns may be discussed at appropriate times and places.
- Demonstrate a respect for the privacy of all student athletes and an understanding of the coaches' responsibilities to all students, by refraining from speaking with coaches about such issues as playing time, athletic ability, and team strategy, insofar as those subjects relate to students other than their own child.

INFORMED CONSENT:

By its nature, participation in interscholastic athletics includes risk of injury and transmission of infectious diseases such as HIV, Hepatitis B, herpes and others. Although serious injuries are not common and the risk of HIV transmission is also nonexistent in supervised school athletic programs, it is impossible to eliminate risk. Participants have the responsibility to help reduce that risk. Participants must obey all safety rules, report all physical and hygiene problems to their coaches/staff, follow proper conditioning programs, and inspect their own equipment daily.

CODE VIOLATIONS:

Students will comply with all state, local laws and education code as well as all school district policies and regulations. Students are required to comply with all Education Codes 24 hours a day, seven days a week in order to remain eligible for participation. Any student who chooses to participate in athletics and who violates the Code of Conduct in any way

may experience disciplinary consequences. Disciplinary consequences for violations of the Code of Conduct for suspension related offenses are as follows:

For violation of Education Code 48900 (a-t):

- (a) (1) Caused, attempted to cause, or threatened to cause physical injury to another person
(2) Willfully used force or violence upon the person of another, except in self-defense
- (b) Possessed, sold or otherwise furnished a dangerous object
- (c) Unlawfully possessed, used, sold or furnished alcohol or controlled substance
- (d) Offered, arranged or negotiated the sale of a controlled substance
- (e) Committed or attempted to commit robbery or extortion
- (f) Caused or attempted to cause damage to school property or private property
- (g) Stole or attempted to steal school property or private property
- (h) Possessed or used tobacco, products containing tobacco or nicotine products, including, but not limited to, cigarettes, cigars, mini cigars, clove cigarettes, smokeless tobacco, snuff, chew packets, and betel. However, this section does not prohibit use or possession by a pupil of his or his own prescription products
- (i) Committed an obscene act or engaged in habitual profanity or vulgarity
- (j) Unlawfully possessed or unlawfully offered, arranged, or negotiated to sell drug paraphernalia
- (k) (1) Disrupted school activities or otherwise willfully defied the valid authority of supervisors, teachers, administrators, school officials, or other school personnel engaged in the performance of their duties.
- (l) Knowingly received stolen school property or private property
- (m) Possessed an imitation firearm
- (n) Committed or attempted to commit a sexual assault
- (o) Witness intimidation or harassment
- (p) Unlawfully offered, arranged to sell, negotiated to sell, or sold the prescription drug Soma
- (q) Hazing
- (r) Engaged in an act of bullying
- (s) As used in this section, "school property" includes, but is not limited to, school grounds, going to or coming from school, during school-sponsored activity, electronic files and databases
- (t) Aiding and/or abets, the infliction of physical injury to another person

In addition to the disciplinary actions and consequences assigned by the school administrators, students involved athletics are also subject to the following:

First Step: Automatic suspension from athletic participation for no less than 20% (i.e. 10 game season results in 2 game suspension) of that competitive season's scheduled contests (whichever is greater) from the first date of disciplinary action. The student is required to attend all meetings, sessions and practices and must participate in every group/team activity, but may not compete or perform.

Second Step: Automatic suspension from athletic participation for no less than 50% (i.e. 10 game season results in 5 game suspension) of that competitive season's scheduled contests (whichever is greater) from the first date of disciplinary action. The student is required to attend all meetings, sessions and practices and must participate in every group/team activity, but may not compete or perform.

Third Step: Automatic suspension from athletic participation for the duration of the school year. The student will be placed on probation for the following year and a subsequent violation while on probation will result in the student being denied further athletic participation for the remainder of the school year.

- **Students that provide a place or location for committing an illegal act will automatically move to the Second Step above.**
- **Students who self report their own code infraction will have the opportunity to receive a lesser penalty and/or reduced suspension.**
- **Team Captains/Life of a Tiger Leaders who violate any of the violations above will automatically move to the Second Step above.**

Bullying and Harassment Policy

Patterson Unified School District believes that all students have a right to a safe and healthy environment. The district, schools, and community have an obligation to promote mutual respect, tolerance, and acceptance.

Students will not engage in cyber-bullying, participate in sending or creating inappropriate cyber images or be seen in an inappropriate cyber image.

Patterson Unified School District will not tolerate behavior that infringes on the safety of any student. A student shall not intimidate or harass another student through words or actions. Such behavior includes: direct physical contact, such as hitting or shoving; verbal assaults, such as teasing or name-calling; and social isolation or manipulation. This includes cyber-bullying, threatening or harassing another student through any social networking site or electronic media device (i.e., texting, sexting, cyber imaging).

Patterson Unified School District expects students and/or staff to immediately report incidents of bullying to the principal or designee.

FELONY VIOLATIONS:

Commission of any felony criminal offense or any juvenile offense that would be a felony if the student were an adult. This section is also applicable 24 hours per day, seven days a week.

First Step: Suspension from athletic participation for no less than 40 days of school from the first date of disciplinary action.

Second Step: Suspension from athletic participation for the duration of the school year. The student will be placed on probation for the following year, and a subsequent violation while on probation will cause the student to be denied further athletic participation for the remainder of the school year.

DUE PROCESS REVIEW:

- Students suspended from athletics will be notified in writing by the principal or his/her designee of the suspension and the basis thereof, as soon as practical after the school official becomes aware of the basis for the suspension.
- Student and parent may contact the Principal or designee to appeal the suspension from athletics within 5 school days of the suspension notice and be entitled to a conference with the Principal or designee within 5 school days of requesting the appeal.
- If the student and parent are not satisfied with the results of the conference referred to in paragraph above, they may have the decision reviewed by the superintendent or designee by requesting **an appeal** within five (5) school days of receiving the notification of the decision referred to in paragraph B above. The superintendent or designee will have 10 school days to review the case and meet with the parent and student and make a decision.
- If the student and parent are not satisfied with the decision of the superintendent/designee, they may appeal the decision to the school board. The school board may choose not to consider the appeal in which case the decision of the Superintendent is final. The school board may choose to consider the appeal, in which case the appeal will be scheduled during the closed session of a regularly scheduled board meeting. The request for the appeal must be made no less than 10 days before the next scheduled board meeting, or it will be held over to the next meeting. The decision of the board shall be final.
- During the appeal process as noted above, the suspension from athletics remains in effect pending the outcome of the appeal.
- The process provided for herein is intended to be informed in nature and shall in no way be intended to confer a right to appeal or hearing, other than as specifically provided for herein.

AGREEMENT FOR COMPLETE DRUG AND ALCOHOL BAN:

- Student athletes are expected to never use, possess, sell or be in the presence of and location of illegal alcohol or drugs as defined in Education Code 48900 at any time (24 hours a day, seven days a week, 365 days per year).
- This expectation is in effect at school or away from school.
- Additionally, athletes may not host or remain present at events, activities, or locations where illegal distribution of alcohol, drugs, or other controlled substances are present and/or being used.
- If a student attends a party/gathering where alcohol or drugs are being consumed and/or illegally dispensed, the student must leave the party/gathering immediately – and take as many of your teammates with you as possible.
- The student must report their attendance to a coach or school administrator before the end of the next school day.
- Because possession and use of alcohol or drugs by youth is against the law, it is our intent to prevent any student from being in an environment which greatly increases the risk of danger and negative behaviors.

Violations verified by a school or district employee and/or a law enforcement officer will require the disciplinary consequences described below:

First Offense: Automatic suspension from athletic participation for no less than 20% (i.e. 10 game season results in 2 game suspension) of competitive scheduled contests from the first date of disciplinary action. The student is still required to attend all meetings, sessions and practices and must participate in every group/team activity, but may not compete or perform. As a pivotal part of the consequences for a drug and alcohol violation, the student shall be required to participate in an alcohol/drug screening and education program. The screening and education is a part of the process that may lead to resumption of participation in the activity.

If the offense occurs at the end of the season, the penalty carries over to the next season sport or activity until the full disciplinary consequence is fulfilled. If the school year ends during the First Offense disciplinary period, it will resume at the beginning of the new school year's sport or activity. Any subsequent violations will move to the Second Offense.

Second Offense: Automatic suspension from athletic participation for no less than 50% (i.e. 10 game season results in 5 game suspension) of competitive scheduled contests (whichever is greater) from the first date of disciplinary action. The student is required to attend all meetings, sessions and practices and must participate in every group/team activity, but not compete or perform. As a pivotal part of the consequences for a drug and alcohol violation, the student shall be required to participate in an alcohol/drug screening and education program. The screening and education is a part of the process that may lead to resumption of participation in the activity.

Third Offense: Automatic suspension from athletic participation for the duration of the school year. The student will be placed on probation for the following year and a subsequent violation while on probation will result in the student being denied further athletic participation for the remainder of the school year.

BAN ON USE OF ANDROGENIC/ANABOLIC STEROIDS:

Student athletes and their parents, legal guardians/caregivers agree that the student shall not use androgenic/anabolic steroids without the written prescription of a fully licensed physician (as recognized by the AMA) to treat a medical condition. Student athletes and their parents, legal guardians/caregivers also recognize that under CIF bylaw 200.D, there could be penalties for false or fraudulent information. Student athletes and their parents, legal guardians/caregivers also understand that District policy regarding the use of illegal drugs will be enforced for any violations of these rules.

ACKNOWLEDGMENT AND ASSUMPTION OF POTENTIAL RISK:

- I understand and acknowledge that the activities of athletic teams, by their very nature, pose the potential risk of serious injury/illness to individuals who participate in such activities.
- I understand and acknowledge that some of the injuries/illnesses which may result from participating in activities include, but are not limited to, the following: Sprains/strains; fractured bones; unconsciousness; head and/or neck injuries; paralysis; loss of eyesight; communicable diseases; death.
- I understand and acknowledge that participation in these activities is completely voluntary and as such is not required by the district for course credit or for completion of graduation requirements.
- I understand and acknowledge that in order to participate in these activities, I and my son/daughter agree to assume liability and responsibility for any and all potential risks which may be associated with participation in these activities.
- I understand, acknowledge, and agree that the District, its employees, officers, agents, or volunteers, shall not be liable for any injury/illness suffered by my son/daughter which is incident to and/or associated with preparing for and/or participating in this activity.
- I acknowledge that I have carefully read this PARTICIPATION AGREEMENT FOR CIF VOLUNTARY ACTIVITIES and that I understand and agree to its terms.
