#### What is Drug Diversion?

PC 1000, also known as Deferred Judgment Program allows eligible persons the opportunity to have their criminal proceedings suspended while they complete a drug education/treatment program. When the person successfully completes the program, the judge dismisses the charges and (with some exceptions) the individual may truthfully state that he/she has never been arrested for the charged offense.

Stanislaus County offers three certified Drug Diversion/PC 1000 providers with two levels of service, Tier I and Tier II.

Tier I is education

Tier II is treatment
